Kind reference is invited towards PA wing Postal Directorate recent transfer OM no.301/(06/2019-PA Admn III/7023 to 7417 dated 27.08.2021, in this connection I would like to draw your kind attention towards the representations & grievances of the officers who were transferred under this said transfer order as well as some other officers grievances whose request transfers at their home stations were not considered in the said order. In many cases AAOs of high rankers in seniority were transferred whereas their juniors were retained, other side who are already officiating in AO grade were also transferred without their requests.

Their representations may kindly be considered in view of IP&TAFS Transfer Policy and considering mid of educational session etc grounds sympathetically & very soon please. In the meantime, relieving process of such officers may kindly be kept in abeyance please.

Secondly, in this transfer order Association's recently elected seven Circle Secretaries were transferred and some of them belong to SC/ST category (A list of Circle Secretaries transferred under this OM is attached for ready reference). Their requests for retention at present stations may also kindly be considered during mid of the session as per provisions & guidelines in this regard.

Therefore, we humbly request your good self to direct the concerned authorities to consider the representations of these officers on this issue & hope for a positive & early response, lease.
