- (vi) All CHQ Members/Circle representatives (President/Circle Secretary) are required to present a report to CHQ on their important activities, particularly (a) details of meetings held with the Head of Circle and outcome thereof (b) pending issues with Circle/DOT-DOP Headquarters/Central Govt. and (c) suggestions to strengthen the Association etc.
- (vii) Apart, all CHQ Members/Circle representatives (President/Circle Secretary) are required to submit their considered views/comments on the following important issues:
 - (a) Cadre review of IP&TAFS Group "A".
 - (b) Proposed Cadre review of IP&TAFS Group "B".
 - (c) Proposed 2nd Cadre review of IP&TAFS Group "A".
 - (d) RRs of Group 'B' Accounts Cadre.
 - (e) RRs of Group 'A' IP&TAFS.
