The mandate of the committee shall include but not limited to: -

- a) Examine the current training structure in toto and suggest steps to overhaul and modify the existing processes.
- b) Study the best practices being implemented by other academies of All India Services and Central Services of the Government of India like LABSNA and NADT etc.
- c) Proposing newer training modules within the existing training schedule of IPTAFS trainee as well as working officers.
- d) To examine existing structure of assessment of training and provide assessment/weightage system and its impact on inter-se-seniority of probationers as per GOI policy.
- e) Leave, joining time and lien leave etc. for probationers w.r.t. writing UPSC exams again.
- f) Protocol, etiquette, discipline, security and standardization etc.
- g) Collaboration with foreign bodies and academic institutions (CoE).
- h) Logo, moto, aim and tagline etc. for service and training institute.
- i) Attachments and tie ups with similar institutes/organisations within India for probationary training etc.
