Constitutional Amendment

As per the Powers vested to the General Body of the All India Conference in Part I article (9) read with article 7(b) of part II(CHQ) of the Constitution, the General Body of the All India Conference which is the Supreme Body of the Association has unanimously passed the following Constitutional amendment, which is coming into effect 06/9/2019.

“Under article 4 (e) of part II (Central Headquarters of Association) the following amendments are made”

Existing provision	Amended provision
<p>Term of office Bearers:</p> <p>i) The office bearers of Central Working Committee/Central Secretariat /Circle Executive committee shall hold office for a period of two years from the date of assumption of charge or till such date the newly elected committee assumes charge.</p> <p>ii) Office bearers are eligible to seek re-election provided they are not otherwise disqualified.</p> <p>Note: No office bearer shall continuously hold the same post for more than three terms.</p>	<p>Term of office Bearers:</p> <p>i) The office bearers of Central Working Committee/Central Secretariat /Circle Executive committee shall hold office for a period of two years from the date of assumption of charge or till such date the newly elected committee assumes charge or till his/her retirement from service, whichever is earlier</p> <p>ii) Office bearers are eligible to seek re-election provided they are not otherwise disqualified.</p>
