**OFFICE MEMORANDUM**

This office is also in receipt of requests from applicants directly addressed to various authorities i.e to Member (F), Advisor (Finance), DDG (FEB), Director (SEA), Secretary (P), Member (P), JS&FA, DDG (PAF), Director (B&A) and ADG (PA Admn) etc. for transfer/deputation etc. by post, FAX, e-mail etc. This is causing a lot of inconvenience to the Department. Such requests, if any, received may be forwarded to DDG (PAF), Department of Posts along with specific recommendations/comments of Head of PAO & CCA concerned.
- v. The requests/grievances received directly from the applicants will not be entertained. Requests received through proper channel will be considered at a appropriate time.



This issues with the approval of Member (Finance), Telecom Commission.


