Subject: Special Limited Departmental Competitive Examination for promotion to the cadre of Assistant Accounts Officer (90% DE quota) held on 29th and 30th December 2012- Announcement of result thereof-reg.

Sir,

I am directed to say that the result of above mentioned examination is indicated in the enclosed Annexure consisting of Two Parts, 'A' & 'B'.

2. Part 'A' of the Annexure contains the list of candidates who have qualified in the examination.
3. Part 'B' of the Annexure contains list of those candidates whose admission to the examination was Provisional. Result in respect of 'Provisional' candidates will be announced only after their candidature is regularized.
4. The selection of the candidates is based on the following Eligibility Criteria for qualifying in the examination:

OC Candidates	40% marks in each subject and 45% in aggregate provided that a minimum of 40 % is also secured in practical papers
SC/ST Candidates	33% marks in each subject and 38% in aggregate provided that a minimum of 33% is also secured in practical papers

5. Compliance of the direction if any, issued by the Court having bearing upon the declaration of the result may also please be ensured before conveying the result to the candidates.
6. The information relating to the names of the candidates, category and Roll Numbers concerned have been shown, as furnished by Circle/Units/Supervising Officers concerned. The Circles are requested for verifying the details before communicating the result and in case if any mistake in the names and other particulars of candidate(s) is noticed the same may please be corrected under intimation to this office for making necessary correction in the relevant records.
7. In case, subsequently, if it is found that any of the qualified candidate (s) was not eligible to take the examination under the extant rules or instructions on the subject for any other reasons or in case any mistake is found with regard to announcement of the result of any candidate for any reason what so ever, his/her name will be deleted from the list of qualified candidates, as the case may be.

8. It is informed that the names of the successful candidates have been arranged in the order of total aggregate marks secured. In respect of candidates who got equal marks in the total will be determined on the basis of marks secured by him/her in the Subject I (Paper VI). If in any case, if there are candidates who happens to secure equal marks in Subject I, also, the total marks obtained in Subject II (Paper VII & VIII) will be made criteria for the purpose of fixing of the rank. In respect of candidates who had claimed exemption without actual marks secured by the candidates as communicated by the Department, sixty percent of the marks in each subject have been taken as marks secured by the candidate. In respect of those candidates who had claimed exemption with the actual marks secured by the candidates as communicated by the Department is taken for computation of aggregate marks, as no records are available either in the DE Section or in the PA Wing of the Postal Directorate.

9. The marks of provisionally permitted candidates for different reasons will not be communicated until and unless their provisional candidature is regularized. This may be made clear to all concerned.

10. Applications under RTI Act for supply of photocopies of answer scripts will be entertained in the following manner:

a. Candidates, who wish to have the copies of Answer scripts supplied are required to pay a fee of Rs. 25/- per paper with Key + Rs. 10 towards the fee for application under RTI Act in the Post Office Accounts and submit their applications through their respective Circle offices concerned along with the receipt for payment of fee in original. Circle Office will prepare a consolidated list and sent to the Directorate for necessary supply. The Individual applications received direct for supply of answer scripts will not be entertained.

b. The period of preservation of answer scripts is one year from the date of declaration of this result. Therefore, applications received after one year for supply of photocopies of answer scripts will not be entertained.

c. Photocopies of answer scripts will be supplied to the candidates only those who have actually appeared in the examination. Therefore, the candidates should invariably intimate their Roll Number in the Application made under RTI.
