**ORDER**



- The promotion of the officers is further subject to the condition that no disciplinary/vigilance case is pending against the officers. In case of any disciplinary/vigilance case of the type referred in DOP&T OM no. 22011-4/91-Estt. A dt. 14.09.92 is pending against the officer or some punishment is current, he should not be promoted and the matter should be reported to this office immediately.
- The above promotion is purely on temporary and adhoc basis and these officers would have no claim for their seniority in STS Gr. 'A' based on this promotion.
- Local officiating arrangements in respect of those officers listed above, if any, should be terminated before the officer assumes charge in STS Gr. A in terms of this orders.
- The pay of the officers on promotion to the grade of STS as above will be fixed under FR 22-(I) a (1) read with FR-35 with reference to their pay in the substantive grade.
- The Head of the offices should ensure that the officers are relieved promptly to join their new assignment within 40 days positively. No leave should be granted to the officers after being relieved from the present office. If the officers fail to join at the new post, it will be presumed that they are not interested in adhoc promotion and the orders shall be deemed to have been cancelled automatically without any further communication. No such officer shall be given local officiating promotion in the grade.
