Subject :- Request for grant of formal meeting with the representatives of the Association- regarding.

Respected Madam,

The Association feels immense honour while requesting your goodself kindly to refer our letter dated 09.04.2013 under which a request for permitting a formal meeting with the representatives of the Association was made but the same could not be permitted so far.

In between, our cadremen are facing too much problems which need immediate redressal and this is possible only when personal discussions with the representatives of the Association are held in which we can suggest the ways and means to solve the problems keeping in view the interest of the Department as well as the welfare of the cadremen. The worst effected cadre during last couple of the years, has been AAO cadre who can neither feel happy on their promotion nor express their sorrow as no body is there to listen their grievance sympathetically. Those who have been posted outside their circles and working away from their families for more than 3 years, are in acute sufferings as if they have committed some wrong while accepting the promotion in as much as they are loosing more while getting less benefit after promotion. Most of the families have achieved damaged career of their children besides several mental, physical & economical loss to the heads of their family. It is not understood as to what constraints administration has got in transferring such AAOs despite sufficient vacancies available in their home circles.

The second most horrible problem is due to transfer policy which made the AAOs/AOs/Sr AOs compulsarily to be posted out of their home circle on promotion. This has created a lot of problems to the cadremen all over the country and there is no hope to reduce the problem in as much as the officers on their promotion are still being posted far away from their home circles viz; From Patna to Jammu, from Luchnow to Bhubaneswar, from Nagpur to New Delhi, from Hyderabad to Trivendrum etc. despite vacancies available in the neighbouring circles. Such chain of disturbances does not stop unless the transfer policy is suitably modified.


It may not be out of point to mention here that all the Group 'B' officers of P&T A&F Service were very happy & hopeful when merger had taken place w.e.f. 01.09.2009 with the hope that Cadre Controlling Authority being from P&T A&F Service will sympathetically consider our problems but the expectations could not be fulfilled for this reason or that. **Not even a single formal meeting has been allowed to the Association by the Cadre Controlling Authority** so far. Recognition to the merged Association could not be finalised. RRs in respect of JTS & STS are not prepared even after three years.

All these and other more problems can be solved only when regular meetings with the Association are held and its submissions are positively & sympathetically considered by the Administration. We assure that whatever demands we are raising/will be raised, it will be extremely in the interest of the Department, within the frame work of rules/instructions and within the competency of the Cadre Controlling Authority.

The Association, therefore, once again requests your goodself kindly to permit a formal meeting with the representatives of the Association in the month of May 2013 so that all the problems may be discussed in detail and sorted out as far as possible.
