
## OFFICE MEMORANDUM

- 2. The promotion of the Officer(s) as in para (2) above is subject to the condition that no disciplinary/vigilance case of the types referred to in the Department of Personnel and Training OM No.22011/4/91-ESTT.(A) dated 14.9.1992 is pending against them and such case, if any, be referred to the Directorate, and no promotion be made. Further if in respect of any Officer some punishment like stoppage of increment, etc. is current, he/she should not be promoted/relieved on promotion and his/her case should be reported to this office immediately.
- 3. In case the Officer is officiating on local arrangement basis in the grade of Accounts Officer, he/she should be reverted to his/her substantive grade i.e. AAO and be promoted afresh in compliance with this order, after giving a break for one day.
- 4. In respect of Reserved category candidates i.e. SC/ST candidates promotion of the candidates is provisional subject to verification of their caste status. Head of the Office will take an undertaking from the Officers to this effect at the time of their relieving and ensure verification of caste status within one month. After verification necessary entries may invariably be made in the Service Books of the officers concerned in terms of instructions contained in DOP&T O.M. No.36011/16.80-Estt(SCT) dated 27.2.81, No.42012/8/87-Estt.(SCT) dated 14.10.87 and O.M. No.36012/36(22)/89-Estt.(SCT) dated 16.6.89.
- 5. If the Officer is on leave/training, he/she shall be promoted with effect from the date of joining on return from such leave/training.
- 6. The Officers named in para (1) above are eligible to exercise the option as envisaged under FR 22 (I)(a)(1) within the period prescribed therein.
- 7. Heads of Circle Postal Accounts Offices/Controllers of Communication Accounts/Under Secretary (SEA) concerned should communicate this order alongwith orders issued by DDG (PAF)/DDG (FEB) as contemplated in para 1 ante to the Officer(s) concerned immediately. The officers may be immediately relieved by the authorities concerned to report for duty on promotion in the place of their posting.
- 8. Refusal for promotion is subject to consideration by the appointing authority. If the same is not acceptable to the appointing authority, the promotion may be enforced. If the Officer still refuses to accept promotion, then even disciplinary action can be taken against the Officer for refusing to obey the orders of the competent authority. In cases



where, such refusals of promotion/deemed refusal made by the officials are accepted by the appointing authority, they would automatically be placed under embargo for a period of one year as under:-

- i) In case of refusals received within one month, from the date of application declining the promotion:
- ii) In all other cases, on the expiry of one month from the date of issue of these orders.

Such officer(s) will not be promoted on adhoc/officiating basis till the expiry of period of embargo.

- 9. Copies of Charge Report may be furnished to all concerned.
- 10. The inter-se-seniority of the Officers will be communicated separately.
