4. In case the officers are officiating on local arrangement basis in STS, they would stand reverted to the substantive grade for one working day before assuming charge in JTS Gr. 'A' in terms of this order.
5. The promotion of the officers is further subject to the condition that no disciplinary/vigilance case is pending against the officers. In case any disciplinary/vigilance case of the type referred to in DOP&T OM dated 14.9.92 is pending against the officer or some punishment like stoppage of increment is in currency, he should not be relieved on promotion and the matter should be reported to this office immediately.
5. Shri K. S Ganesh, JTS regular officer posted in O/o CCA Karnataka is hereby transferred to O/o CGCA, New Delhi with immediate effect.
