3. The above appointments are not in order of seniority. The inter-se-seniority of the officers promoted to the Junior Time Scale of Indian P&T AFS Group 'A' will be issued separately.

The simultaneous promotion to the Senior Time Scale of the officers is purely on adhoc and temporary basis and will not bestow any claim on the officers for regular promotion to the STS nor will the services rendered in the Senior Time Scale count for purpose of seniority in the grade and for promotion to the next higher grade.

5. The promotion of the officers is further subject to the condition that no disciplinary/vigilance case is pending against the officers. In case any disciplinary/vigilance case of the type referred to in DOP&T OM dated 14.9.92 is pending against the officer or some punishment like stoppage of increment is in currency, he should not be relieved on promotion and the matter should be reported to this office immediately.
