



2. The above promotion will be for a period of 180 days from the date of assumption of charge or till date of regular promotion, whichever is earlier.
3. This promotion will neither confer any right for regular promotion to the cadre of Sr. Accounts Officer nor continuance of officiating promotion in the cadre. This will also not count for any other purpose i.e. seniority and promotion to any higher grade etc. The promotion is purely of adhoc nature and liable to be terminated at any time without assigning any reason.
4. The promotion is subject to the condition that no vigilance/disciplinary case is pending/being contemplated against any of the officers mentioned above. Any such case may be informed to this office immediately.
5. On promotion to the post of Sr. Accounts Officer cadre their pay will be fixed under FR 22-1 (a) (i) with reference to their pay in the cadre of Accounts Officer cadre.
6. Promotion order based on the O.M. be issued immediately and communicated to all concerned including the officers concerned and further action taken.
